Subject: GRANT OF INCREASE IN PENSION TO CIVIL PENSIONERS OF THE
PROVINCIAL GOVERNMENT.

Dear Sir,

The Competent Authority, is pleased to sanction, w.e.f **1st July, 2018** and until further orders, an increase @ 10% in net pension of the Pensioners of Khyber Pakhtunkhwa Government.

2. The 15% increase in pension allowed vide para-12(i) of the Finance Department's circular No.FD (PRC)1-1/2011 dated 14-07-2011, 10% increase in pension as allowed vide para-1 of this department letter bearing No. FD(SOSR-II)4-111/2015 dated 14-07.2015 and 10% increase as allowed vide Finance Department circular No. FD(SOSR-II)4-111/2016 dated 14.07.2016 shall also be admissible to the new pensioners who would retire on or after 01.07.2018

3. The 10% increase in pension as mentioned at para-1 above will also be admissible to the pensioners who would retire on or after 01-07-2018.

4. For the purpose of admissibility of increase in pension sanctioned through this letter the term "Net Pension" means "Pension being drawn" minus "Medical Allowance",

5. The increase will also be admissible on family pension granted under the Pension-cum-Gratuity Scheme, 1954, Liberalized Pension Rules, 1977, on pension sanctioned under the Provincial Civil Services (Extra Ordinary Pension) Rules as well as on the Compassionate Allowance under CSR-353.

6. If the gross pension sanctioned by the Provincial Government is shared with any other Government in accordance with the rules laid down in part-IV of Appendix III to the Accounts Code, Volume-I, the amount of increase in pension will be apportioned between the Government of Khyber Pakhtunkhwa and the other Government concerned, on proportionate basis.

7. The increase in pension sanctioned through this circular will not be admissible on Special Additional Pension allowed in lieu of pre-retirement orderly allowance.

8. The benefit of increase in pension sanctioned vide this circular will also be admissible to those Pensioners of Khyber Pakhtunkhwa Government, who are residing abroad (other than those residing in India & Bangladesh) who retired on or after 15-08-1947 and are not entitled to, or are not in receipt of pension increase under the British Government's Pension (increase) Acts. The payment will be made at the applicable rate of exchange.


