Further to amend the North-West Frontier Province Hydel Development Fund Ordinance, 2001.

Preamble - WHEREAS it is expedient further to amend the North-West/Frantier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ord. No.XXVI of 2001), for the purposes hereinafter appearing,

It is hereby enacted as follows:-

- Short title and commencement -(1) This Act may be called the North-West Frontier Province Hydel Development Fund (Amendment) Act, 2006.
 - (2) It shall come into force at once.
- Amendment of section 3 of N.-W.F.P. Ord. No. XXVI of 2001. In the North-West Frontier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ord. No. XXVI of 2001), hereinafter referred to as the said Ordinance, in section 3, after subsection (8), the following new sub-section shall be added, namely:
 - "(5). An Investment Committee, consisting of the following, shall be constituted to make recommendation to the Board for making investment out of the Fund:

1.	Chief Secretary to Government	Chairman.
2.	Secretary to Government, Irrigation and Power Department	-Member
3.	Secretary to Government, Finance Department.:	-i vlember
4.	Managing Director, SHYDO	Member
5.	Director Finance and Administration SHYDO.	Member."

- Amendment of section 4 of N.-W.F.P. Ord, No. XXVI of 2001 In the said Ordinance, in section 4, in sub-section (3), for the word "three", the word "four" shall be substituted.
- Amendment of section 7 of N.-W.FP. Ord. No. XXVI of 2001 in the said Ordinance, in section 7,-
 - (a) in sub-sections (1) and (3), for the words "Irrigation and Power Department", the words "Finance Department" shall be substituted; and
 - (b) in sub-section (2), for words "Chief Secretary", the words "Secretary Finance" shall be substituted.

5. Repeal. The North-West Frontier Province Hydel Development Fund (Amendment) Ordinance, 2006 (N.-W.F.P. Ord. No. II of 2006) is hereby repealed.
