NOTIFICATION

NO.FD(SOSR-II)4-199/2013. In pursuance to the judgments of the Peshawar High Court Peshawar dated 12/09/2012 in WP.No.2976/2011, dated 11/10/2012, WP No.519-A/2012, dated 15/03/2013 and COC No.85-A/2012 the Government of Khyber Pakhtunkhwa has been pleased to modify this Department Notification of even No. dated 22/02/2011 revise4vide notification dated 21-01-2014 in supersession of letters/notifications dated 24-11-2009, 22-03-2010 and 27-07-2010 and issue a single consolidated uniform compensation package for legal heir of the Provincial Police Personnel and All Persons in the service of Provincial Government or working on civil posts in connection with affairs of the province, who while in service, are martyred, incapacitated for further service or seriously injured due to acts of terrorism, as defined in Section-6 of the Anti Terrorism Act, 1997, irrespective of the facts whether they meet such incidents either during the performance of their respective official duties or otherwise, as per detail given below:-

2. In pursuance of the provisions of Para-1(b) above, in all cases of martyrdom occurring on, or after, 19/04/2010, no plot of land will be allotted to any legal heir of the martyr, free of cost or at concessional rates or in relaxation of any rule or order.

3. All other facilities currently admissible to the legal heir of the aforesaid regular employees martyrs, but not revised, varied or modified through this Notification, shall continue to be admissible to them, subject to such conditions as may have been prescribed in the notifications/orders issued from time to time.

4. The Cash Compensation and Cash Payment in lieu of plot of land (a & b) shall be admissible to the legal heir of Shaheed Government employees as detailed below:

- Provincial Police Personnel whether regular or contract.
- ii. All Civil Servants as defined in Khyber Pakhtunkhwa Civil Servant Act 1973.
- iii. A Government servant, who is on deputation to the Province from the Federation or any other Province or Authority, including APUG officers serving in the Province.
- A person who is employed on contract, or work-charged basis, or who is paid from contingencies, including employees appointed on Ad-hoc basis.
- v. Employees working against posts in various projects being funded by the Provincial Government.

vi. Employees working against posts in various projects being funded by the Federal Government, the administrative control of which vests with the Provincial Government.

vii. Employees of autonomous and semi autonomous organizations of the Provincial Government.

viii. The compensation package shall be treated as legacy (Tarka) of the deceased employee and distributed amongst the legal heir as per succession certificate in accordance with relevant law of inheritance and succession as per notification No.FD(SOSR-II)4-199/2014 dated 13-06-2014.

5. All the facilities allowed to the family/legal heir of the martyred regular Police Personnel/civil servants from time to time vide Finance/Establishment Department letters noted below shall remain continue to be admissible subject to the same conditions as are prescribed in respective orders:-

6. All the facilities, other than mentioned in Para-5 above, currently admissible / available to the Civil Servants / Police Personnels under their relevant/specific rules/policies shall remain to be admissible under the terms and conditions prescribed by the Provincial Government from time to time.

7. The facilities mentioned at Para-5 above **except pensionery benefits** will be admissible to the families of police personnel and other employees recruited on adhoc, contract, contingent paid staff, work charge employees and fixed pay employees till the expiry of their period as per terms and conditions of their appointment.

8. Financial Assistance currently admissible to the family of deceased Government servants, who dies while in service, under this Department Circular letter No.FD/SOSR-II/4-199/02/Vol-III dated 16/02/2006 shall not be admissible to the family/legal heir of all such employees, to whom this Uniform, Compensation Package is extended / allowed.

9. To ensure timely and speedy relief to the family/legal heir of Shuhada, all the Departments/organizations make sure to take the following measures/arrangements:

- All autonomous/semi autonomous organizations of the Provincial Government will make necessary provision in their respective budgets for their employees.
- Provision will be made in estimates of all new projects to cover employees of respective projects.
- c) For employees of on-going projects, either the respective PC-I/PC-II may be revised or a separate composite PC-I may be prepared for the purpose.
- d) In all cases, provision made for the payment of compensation, as such, shall not be expended or utilized for any other purpose.
- Note:- For the purpose of this Notification "Authority" referred to in Para-4(iii) above, means a properly authorized / appointed officer of autonomous/semi autonomous organization or any other legal entity, the administrative control of which vests in the Federal or any Provincial Government.

10. The Education package/scholarship notified under this Department Notification No.FD(SOSR-II) 4-199/2010 dated 25/11/2010 currently admissible to the children of Police Shaheed Personnel will also be admissible to the children of civil servants of the Provincial Government.

11. Finance Department letter No.FD(SOSR-II)4-199/2009 dated 30/03/2009 and Establishment & Administration Department letter No.SOR-II/E&AD/I-10/2009 dated 01/10/2009 shall stand amended only to the extent covered by this Notification. Accordingly, procedure for payment of compensation, as prescribed in the Establishment & Administration Department letter, referred to above, will remain in force.

12. On issuance of this Notification all such notifications, orders and letters on the subject shall stand superseded / amended to the above noted extent.

- Grant of full pay and allowances (except conveyance allowance) i) including annual increments to the families of Shuhada at the revised rates as admissible to all Government Servants till the date of superannuation.
- On retirement at the date of superannuation of the Shaheed Police ii) Personnel, his/her family/legal heirs, as specified in the Civil Servant Pension Rules of NWFP, would be entitled to full pensionary benefits.

2. These orders will take effect from 02-02-2004, however no arrears would be admissible upto 30-06-2010.

2. The Chief Minister N.W.F.P. is pleased to approve the payment of last pay & allowances drawn by the Shaheed Police officials for the remaining period of their service (upto the age of superannuation) with immediate effect subject to the following conditions :-

> (i) Pension will not be attracted in the matter as the bereaved families would qualify for pension only after the remaining period of service upto the age of superannuation has expired.

ii) The financial liability to be caused by this decision will be met out of existing budget and no additional funds will be demanded as savings in the head of pay and allowances are quite substantial every year.

To

Widow of the Shaheed Police official shall be entitled to free medical facilities till the date of superannuation of the Shaheed or remarriage which-ever is earlier. The children of Shaheed Police official shall also be entitled to free medical facilities in Government Hospital till attaining the age of 20 years or superannuation of the Shaheed Police official or whichever is earlier.

I am directed to refer to subject noted above and to say that Government has decided to allow the following package to the families of these Government servants whose death take place due to sectarian violence against Government servants:-

ACCOMMODATION

A

The family of the deceased Government servant shall be allowed to continue living in the Government accommodation till the deceased would have reached the age of superannuation had he not died. In case the deceased's family is not living in government owned house, the family shall be allotted a Government owned/hired house or paid a monthly allowance at the prescribed rate for hiring a house at the option of the deceased's family or if hiring policy is not in vogue, at the prescribed House Rent.

Full Pension shall be allowed to the bereaved family, Full family pension shall continue till the ghildren of the deceased attain the age of majority i.e. 18 years.

(iii) LUMPSHMCANT

An amount of Rs. 0.5 million shall be paid to the family of the deceased government servant within period of 30 days of his death.

ENPLOYMENT

Either the spouse or one child of the deceased Government servant shall be given employment in the Government provided she/he is qualified for the post not above the rank and pay of BPS-16.

v) BOUCATION

Free education shall be provided to the children of the deceased up to the age of 25 years at a Government Institution.

vi) HEALTH

Free health facilities shall be provided to the family of the deceased up to the age of 20 years at a Government Institution.

2. I am further directed to say that the above relief package will be subject to certification by the Inspector General of Police, NWFP that the death is due to sectarian-violence and not because of personal enmity or vendetta.
