## **UNCASHED CHEQUES OF FINANCIAL YEAR 2024-25**

Dear Sir,

I am directed to refer to the subject noted above and to state that certain Departments/Offices are approaching this department for extension of period of validity of uncashed cheques of previous financial year 2024-25 during current financial year 2025-26 which were not cleared/un-cashed due to some reasons. Attention is invited to Rules-162 of the Federal Treasury Rules provides that "Cheques shall be payable at any time within three months after the month of issue but not beyond the 30th June".

- In view of the above rules, all cheques of financial year 2024-25 stand expired on 30-06-2025 and their period of validity can't be extended during current financial year 2025-26. However, in lieu of any un-cleared/un-cashed cheque pertaining to previous financial year 2024-25, fresh cheque may be issued out of the sanctioned budget grant during the financial year 2025-26, subject to availability of funds under the relevant heads.
- All un-cashed cheques in original may immediately be returned back to the concerned Accounts Office(s) for its cancellation, correction and reconciliation of Accounts for the financial year 2024-25.
