No. FD (SOSR-IV)/3-21/2025/Utility Allowance (BPS-19): In pursuance of the decision of the Provincial Cabinet in its special meeting held on 13.06.2025, the Government of Khyber Pakhtunkhwa has been pleased to accord sanction of the Utility Allowance at Rs.18,000/- to the Officers of BPS-19 appointed by the competent authority and working in the Civil Secretariat Peshawar Khyber Pakhtunkhwa w.e.f. 1st July, 2025.


2. The above allowance will be admissible subject to the following conditions:
- It will be subject to Income Tax.
 - It will not be counted towards pension and commutation/gratuity.
 - It will be admissible to employees on Special Duty (OSD), however, the same will not be admissible to employees who are on Extra Ordinary Leave (EOL) or Suspension or on Earned Leave beyond more than 120 days.
 - Officers employed on pay package other than National Pay Scale (Contract, market-based salary scale, etc.) are not entitled to this allowance.
