## MINIMUM PENSION

Dear Sir,

I am directed to refer to this Department circular letter of even number dated 17/07/2013 on the subject noted above and to state that the Competent Authority has been pleased to sanction w.e.f 1<sup>st</sup> July, 2014 and until further orders, increase in minimum pension payable to pensioners of the Provincial Government from Rs.5,000/- PM to Rs.6,000/- PM.

- Similarly, family pension allowed to the family of a retired Government employee under the pension-cum-gratuity scheme 1954, and liberalized pension rules, 1977 has also been increased from current rate of Rs.3,750/- PM to Rs.4,500/- PM.
- Commutation of any part of the increase allowed through this letter will not be admissible.
