Subject: -**GUIDELINES REGARDING SUBMISSION OF CASES TO THE SNE SCRUTINY COMMITTEE**

Dear Sir,

I am directed to refer to this Department's circular letter No.BO.I/ FD/5-8/2019-20/Economy Measures dated 01/07/2019 and to state that the Provincial Cabinet in its Special Budget Meeting held on 24.05.2024 has accorded approval, inter alia, to the proposal that there shall be a complete ban on "Creation of posts excluding completed Developmental Project. In case of exigencies, the Chief Minister, Khyber Pakhtunkhwa may relax the ban on case-to-case basis".

- To examine and determine genuineness of the proposed SNEs both completed 2. Development Projects and Non-Development Schemes and submit viable recommendations for consideration of the Chief Minister, Khyber Pakhtunkhwa, Finance Department has constituted a scrutiny committee, headed by Advisor to Chief Minister for Finance, vide Notification bearing No. BO1/FD/5-8/2024-25 dated 25.07.2024 (copy enclosed).
- While submitting the demands for creation of posts, the following guidelines shall 3. invariably be complied with positively:

A. SCHEDULE FOR NEW EXPENDITURE FOR COMPLETED DEVELOPMENT **SCHEMES**

(i) The requisite information must be provided on the following prescribed format alongwith relevant documents duly singed, to ensure timely and logical decision-making:

ii) However, in case of 75% completed developmental schemes, in addition to above mentioned documents, a certificate, countersigned by Heads of concerned executing Department shall also be required, certifying the expected completion within the remaining period of Financial Year. On completion of such scheme the Department concerned shall provide PC. IV to Finance Department. The demands for creation of additional posts shall be accompanied with previous sanction order of Finance Department with full justification based on HR plan.

B. SCHEDULE FOR NEW EXPENDITURE FOR NON-DEVELOPMENT SCHEMES

The demands for creation of additional posts in the existing entities shall be initiated by the Departments through summary(s) seeking relaxation in ban on creation of posts as mentioned at Para-1 above. In this regard the summary for Chief Minister shall include the following information, so as to reach at logical conclusion of the case:

- a. Function of the Department.
- b. Sanctioned, filled and vacant posts in the Department and office concerned, where the posts are required to be created.
- c. Organogram of the department or sub-department for which the SNE is demanded.
- d. Department/DDO-wise break up of vacant posts; both Settled & MDs.
- e. Designation/BPS-wise detail of demanded posts with financial implications per annum.
- f. Break up of each type of posts into Direct Service Delivery and Indirect Service Delivery, Managerial/Technical, Ministerial and Support Staff.
- g. Justification/Purpose of the demanded SNEs? (How crucial is the creation of this post(s) and what problem (s) will the creation of this post solve)
- h. Prescribed criteria/yardstick.
- i. Recruitment Plan.
- 4. I am further directed to state that the demand for creation of posts against existing entities may be considered keeping in view cash balance/fiscal space if available in the public exchequer. The prime focus shall be to improve service delivery through technical / managerial human resources. Departments may also carry out an exercise to revise their yardstick for SNEs to make them leaner and more service delivery focused; such attempts that can demonstrate value-for-money and potential impact shall be encouraged. The viable outsourcing of support functions as an option will also be encouraged.
- 5. It is requested that the above instructions may kindly be adhered to in letter and spirit.
