NOTIFICATION:

No. FD (SOSR-IV)/3-21/2025/Technical Allowance: In pursuance of the decision of the Provincial Cabinet in its special meeting held on 13.06.2025 and in supersession of all previous notifications regarding Technical Allowance, the Government of Khyber Pakhtunkhwa has been pleased to revise and fix the Technical Allowance to the tune of 1.2 Initial Basic Pay 2022 per month to the Engineers in BPS-17 and above holding engineering qualification from the accredited engineering program of Higher Education institutes (HEI)/Universities duly recognized by the Higher Education Commission (HEC) and registered with Pakistan Engineering Council (PEC), serving against the positions that are required to be filled by the Engineers of the Communication and Works Department, Public Health Engineering Department, Irrigation Department, Mines and Minerals Development Department, and Local Government, Elections and Rural Development Department w.e.f. 1st July, 2025.

2. The above allowance will be admissible subject to the following conditions:
 - i. It will be subject to Income Tax.
 - ii. It will not be counted towards pension and commutation/gratuity.
 - iii. It will be admissible to Officers on Special Duty (OSD), however, the same will not be admissible to officers who are on Extra Ordinary Leave (EOL) or Suspension or on Earned Leave beyond more than 120 days.
 - iv. Those engineers who are posted against other posts and are in receipt of cadre allowance other than regular allowances shall only be entitled to one of the allowances, whichever is more beneficial.
 - v. Officers employed on pay package other than National Pay Scale (Contract, market-based salary scale, etc.) are not entitled to this allowance.
3. All Autonomous/ Semi-Autonomous/ Medical Teaching Institutes/other institutes and authorities under Provincial Government shall adopt this notification within their respective organizations with the approval of the concerned competent forum subject to the availability of their resources.
