NOTIFICATION

No. FD (SOSR-IV)/3-21/2026/Attorneys Performance Allowance: The Provincial Cabinet of Khyber Pakhtunkhwa in its Special Cabinet meeting held on 19.06.2026 has been pleased to enhance Attorney's Performance Allowance being admissible to the Attorney Cadre officers of the Law, Human Rights & Parliamentary Affairs Department, Government of Khyber Pakhtunkhwa from Sixty Percent (60 %) per month of Initial Basic Pay Scales of 2022 to Hundred Percent (100 %) per month of the Initial Basic Pay Scales of 2022, w.e.f. 1st July, 2026.

2. The above allowance will be admissible subject to the following conditions:
 - i. It will be subject to Income Tax.
 - ii. It will not be counted towards pension, commutation or gratuity.
 - iii. It will be admissible during waiting for posting period, however, the same will not be admissible to employees who are on Extra Ordinary Leave (EOL) or placed under suspension or on Earned Leave sanctioned for more than 120 days.
 - iv. The officers of other cadres working against the Attorney's Cadre posts will not be entitled to Attorney's Performance Allowance.
 - v. If Attorney Officers are posted outside of their cadre and that post carry any other allowance other than regular allowances, in that eventuality, the Attorney Officers shall be entitled to one of the allowances whichever is more beneficial.
 - vi. Officers employed on pay packages other than National Pay Scale (Contract, market-based salary scale, etc.) are not entitled to this allowance.
3. Consequently with the issuance of this notification all other notifications & orders in this regard shall stand superseded / ceased to be effective.
