No.SO(SR-II)/FD/5-7/2022 Consequent upon approval of the Provincial Cabinet, accorded in its 68th meeting held on 29.03.2022, the following Compensation Package is hereby notified with immediate effect for Shaheed & Injured employees of Forest Force and Wildlife Force of Forestry, Environment & Wildlife Department, who embraced Shahadat/sustained injuries in the line of duty, on the analogy of the Uniform Compensation Package of the Provincial Government issued vide Notification No.FD(SOSR-II)4-199/2013 dated 16.03.2015.

All other facilities allowed to the family/legal heirs of the martyred regular Police Personnel/Civil Servants as mentioned in Para-5 of this department's Notification dated 16.03.2015 shall continue to be admissible to the above-mentioned officers/officials subject to the same conditionalities.

3. Financial Assistance currently admissible to the family of the deceased Government Servants who die while in service under this department's letter No.FD/SOSR-II/4-199/02/Vol-III dated 16.02.2006 shall not be admissible to the family/legal heirs of the employees to which this compensation package is extended.
4. A Departmental Committee may be notified to determine and to certify that the death/injury occurred is not natural or due to personal enmity but is purely in the line of duty.
5. The above-mentioned package shall only be admissible to the regular field staff officers of the Forest Force and Wildlife Force of Forestry, Environment & Wildlife Department.
