## **NOTIFICATION:**

No. FD (SOSR-IV)/3-21/2025/Scheduled Post Allowance: In pursuance of the decision of the Provincial Cabinet in its special meeting held on 13.06.2025 and in supersession of all previous notifications regarding Scheduled Post Allowance, the Government of Khyber Pakhtunkhwa has been pleased to revise Scheduled Post Allowance to the Police Officers from BPS-17 to BPS-21 to the tune of 1.2 Running Basic Pay per month w.e.f. 1st July, 2025.

The above allowance will be admissible subject to the following conditions: 2.

- i. It will be subject to Income Tax.
- It will not be counted towards pension and commutation/gratuity. ii.
- Risk Allowance and Fixed Daily Allowance will not be admissible to the officers iii. from BPS-17 to BPS-21 who draw this allowance.
- Scheduled Post Allowance will be admissible to only those officers who are iv. posted by Central Police Office Peshawar, Government of Khyber Pakhtunkhwa.
- It will be admissible to Officers on Special Duty (OSD), however, the same will ٧. not be admissible to officers who are on Extra Ordinary Leave (EOL) or Suspension or on Earned Leave more than 120 days.
- It will not be admissible to the officers on deputation to the Police Department. vi.
- Officers of other cadres working against the scheduled posts are not entitled to this vii. allowance.
- Officers employed on pay package other than National Pay Scale (Contract, viii. market-based salary scale, etc.) are not entitled to this allowance.
- This allowance shall not be admissible to the officers in the receipt of Senior ix. Executive Allowance.
