Subject: FINANCIAL ASSISTANCE TO THE FAMILY OF A CIVIL SERVANT WHO DIES WHILE IN SERVICE.

Dear Sir,

I am directed to refer to the above noted subject and to say that untimely death of a civil servant brings economic hardships to its family in the absence of any adequate provision of financial relief. The Provincial Government has therefore been feeling since long the need to provide to a bereaved family of a civil servant, who dies during service, a compassionate grant to compensate for a sudden loss of its bread winner. It has now been decided, with the approval of the competent authority to approve with immediate effect the following grant of financial assistance to the families of civil servants who expire during service. -

| 11-15        | Rs.4,00,000  |
| 16-17        | Rs.5,00,000  |
| 18-19        | Rs.8,00,000  |
| 20 and above | Rs.1,000,000 |

2. This will be in addition to other benefits admissible to the family of a deceased civil servant under any other rules.

3. Expenditure involved will be met out of the existing budget grant of the Administrative Department/District Governments. However, in case additional funds are required the case will be referred to Finance Department for provision of funds with justification.
