#### 5. Payment

The supplier shall give (1) one year comprehensive warranty for the equipment (parts & labor on site of installation) and (3) three years for branded Products, certifying that the goods supplied confirm exactly or above to the specifications laid down in the contract. The supplier will be held responsible for all losses; if any material being found defective or not conforming to specifications or particulars; governing the supply for a period of one year from the date of supply. The unacceptable items shall be substituted with the acceptable items at bidder's expense and cost. An amount equivalent to 5% of total payment (inclusive of 2% earnest money) shall be retained by Project Director (CB&S) Finance Department till the end of Warranty Period.

#### 8. Responsibility for Executing the Contract
