Notification: No.SO(Dev-II)/FD/12-6/2014-15: In furtherance and partial modification of earlier Notification No.SO(Dev-IV)FD/CSR/1-46/2012-13 dated 05.01.2015, the Competent Authority has been pleased to direct that all Provincial Works Departments, while preparing Cost Estimates of development projects which fall in the tax exempted areas such as PATA, shall frame the same on Market Rate System-2015 (MRS-2015 Q-2) but with 7% less cost to defray the amount added in rate analysis of all works/construction/supply items to meet withholding tax.

- 2. The above instructions shall come into force with effect from 1st April, 2015 and shall be applicable to all new contracts of the projects to be undertaken in tax exempt areas such as PATA formulated on MRS-2015 (Q-2).
- 3. All relevant Departments/Offices/Authorities shall ensure to incorporate the above provisions in preparation of cost estimates prior to processing Administrative Approval of the projects.
