## UNCASHED CHEQUES OF FINANCIAL YEAR 2017-18 (CURRENT **BUDGET**)

Dear Sir,

I am directed to refer to the subject noted above and to state that certain departments/offices are approaching this department for extension of period of validity of uncleared/un-cashed cheques of previous financial year 2017-18 during current financial year 2018-19 which were not cleared/un-cashed due to some reasons. Rules 162 of the Federal Treasury Rules provides that "Cheques shall be payable at any time within three months after the month of issue but not beyond the 30th June".

- 2. In view of the above rules all cheques of financial year 2017-18 have expired on 30-06-2018 and their period of validity can't be extended during current financial year 2018-19. However, in lieu of any un-cleared/un-cashed cheque pertaining to financial year 2017-18, fresh cheques may be got issued out of the sanctioned budget grant for the financial year 2018-19, subject to availability of funds in the relevant heads.
- All un-cashed cheques in original may immediately be returned back to the Accounts Office(s) for cancellation, correction and reconciliation of Accounts of financial year 2017-18.
- Similar nature cases pertaining to development grants shall be dealt separately and guidelines will be issued soon.
