NOTIFICATION:

No. FD (SOSR-IV)/3-21/2025/Risk Allowance Rescue 1122: In pursuance of the decision of the Provincial Cabinet in its special meeting held on 13.06.2025 and in supersession of all previous notifications regarding Incentive Allowance to the Officers of Rescue 1122 (BPS-17 to BPS-20) of Relief, Rehabilitation and Settlement Department, the Government of Khyber Pakhtunkhwa has been pleased to revise and fix @ 100% of the Initial Basic Pay 2017 w.e.f. 1st July, 2025.


2. The government of Khyber Pakhtunkhwa is further pleased to rename the Incentive allowance as Risk Allowance Rescue 1122.
3. The above allowance will be admissible subject to the following conditions:
 - i. It will be subject to Income Tax.
 - ii. It will not be counted towards pension and commutation/gratuity.
 - iii. It will be admissible to officers on Special Duty (OSD), however, the same will not be admissible to officers who are on Extra Ordinary Leave (EOL) or Suspension or on Earned Leave beyond more than 120 days.
 - iv. The officers of other cadres working against the Rescue Cadre posts are not entitled to the above allowance.
 - v. Officers employed on pay package other than National Pay Scale (Contract, market-based salary scale, etc.) are not entitled to this allowance.
