Subject: - REVISED PROCEDURE FOR OPERATION OF ASSIGNMENT ACCOUNTS

Dear Sir,

In continuation of this department letters of even number dated 11.11.2009, 23.11.2009, 11.02.2009 and 03.03.2010 on the subject noted above, I am directed to state that to implement the Revised Procedure for operation of Assignment Accounts in Khyber Pakhtunkhwa (circulated vide the Department letters under reference) wherein it was decided that all PLA/SDA holders be informed to forward their applications to Finance Department alongwith NOC of A.G. Khyber Pakhtunkhwa (pre-requisite under Treasury Rule 623-c) for conversion of their PLAs/SDAs into Assignment Accounts before their next release failing which funds will not be released to respective PLA/SDA holders.

2. It has come to the notice of Government of Khyber Pakhtunkhwa that most of the Government Departments/ Autonomous/Semi-Autonomous Bodies/Corporations/Institutions have not implemented these instructions and are still maintaining PLAs/SDAs. This is a serious irregularity and mis-appropriations of public funds on the part of respective Government Departments/ Autonomous/Semi-Autonomous Bodies/Corporations/Institutions.

3. In view of the above, all heads of the Government Departments/ Autonomous/ Semi-Autonomous Bodies/Corporations/Institutions/projects are once again directed to convert all the existing PLAs/SDAs into Assignment Accounts.
