CLARIFICATION REGARDING VERIFICATION OF MEDICAL CHARGES BILLS OF THE SERVING/REITRED CIVIL SERVANTS OF THE PROVINCIAL GOVERNMENT.

Dear Sir,

I am directed to refer to this Department letter No. No So(SR-III)/FD/8-40/2009/Vol-IV dated 21/03/2012 on the subject noted above and to further clarify that :-

The concerned Board/Committee will verify MRC Bills of findoor/OPD, however the claim exceeding Rs.15000/- will further require authentication/clarification from DGHS Khyber Pakhtunkhwa, so as to eradicate the chances of malpractice/misuse.

The retired civil servants and their eligible family members will prefer their claims to the respective Administrative Departments alongwith all relevant record/supporting documents including prescription/discharge slip, bills, cash memos, non-availability certificates etc. duly authenticated by the concerned authorized Medical Attendant of the Hospital. The Administrative Departments after proper scrutiny will issue sanction to this effect to the concerned DCAs/DAOs/AAOs in whose jurisdiction the pensioners are drawing their pension. After issuance of such sanction, the pensioners concerned will present their claims to the respective DCAs/DAOs/AAOs for pre-audit and cross cheques will be issued in the name of such pensioners accordingly.
