## **NOTIFICATION**

**No.FD(SOSR-II)4-199/2013.** The competent Authority has been pleased to approve the Compensation Package until further order for Polio Workers, who martyred / injured due to Act of terrorism as defined in section-6 of the Anti Terrorism Act 1997 during Polio campaign as per detail given below:-

- a) If the martyred/injured worker is a Government servant, he shall be compensated under the existing Uniform Compensation package Notified vide Notification No.FD(SOSR-II)/4-199/2011 dated 22/02/2011.
- b) If the martyred worker is a volunteer, his legal heirs shall be compensated with Rs.10,00000/- (One Million) in cash and Government job for one of the family members.
- c) If the Polio Volunteer Workers is seriously injured, he shall be compensated with Rs. 1,00,000 (One Hundred Thousand) in cash and free treatment at a Government Hospital.
