NO.SO(SR-II)/FD/5-1/2025/Police Shuhada Package. In supersession of this department Notifications No. FDSO(SR-II) 4-199/2013 dated 06.09.2017, the Government of Khyber Pakhtunkhwa has been pleased to enhance Shuhada Package for police personnel only, who embraced shahadat in line of their duties exclusively during combat operation and an act of terrorism with immediate effect as per the following rates mentioned below: -

2. It has further been pleased that henceforth no cash payment in lieu of plot would be made to the legal heirs of Shuhada. However, the legal heirs of Shuhada would be entitled for allotment of plot which will be provided by the Housing Department Government of Khyber Pakhtunkhwa, as per following eligibility criteria: -

3.	DSP/ASP	10 Marla
4.	SSP and above	01 Kanal

3. The above Package is subject to certification by the Provincial Police Officer Khyber Pakhtunkhwa that the death occurred due to combat operation as well as an act of terrorism in line of duty as defined in section 6 & 7 of Anti-Terrorism Act 1997 and not because of personal enmity or other natural causes of death.

4. All other facilities as admissible to Police Personnel regarding the subject matter notified from time to time and incorporated in this department's Shuhada Package Policy dated 16-03-2015 will remain the same.


