Dear Sir.

In partial modification in Para-3 of this Department's circular letter No.BO.I/FD/5-37/2014-15/Policy dated 10.10.2014, it is clarified that the completion certificate to the effect that "75% work of the scheme has been completed and the remaining 25% work will be completed within the time fixed for completion of the scheme" shall be provided by C&W/relevant executing Department, attested by District Officer concerned of devolved entity duly countersigned by District Officer (F&P), Office of Deputy Commissioner concerned. For non-devolved departments, such certificate is to be provided by concerned executing agency and will be attested by Head of the Department. The concerned department will also provide a certificate that letters of appointment will not be issued unless the scheme has been completed 100%. The concerned officers while processing the cases of SNEs shall ensure submission of all relevant documents, duly completed in all respects, to Finance Department for further necessary action.

2. All the Departments are advised to submit audit copies of the posts so created, to Finance Department alongwith PC-IV/completion certificate for authentication. It is added that whereas the process of recruitment may start after approval of SNE the concerned Department shall not issue letter of appointments against the newly created posts till 100% completion of the scheme.

"All the departments, on whose building 75% work has been completed, should take up cases for creation of new posts / SNEs for these buildings with Finance Department on priority basis so that those buildings could be operationalized early. All the District Officers (Finance and Planning) may be instructed to complete all the codal formalities in this regard and PC-IV of such buildings may also be prepared expeditiously and sent to the concerned department".
