NOTIFICATION

No. FD (SOSR-IV)/3-21/2026/Legal Allowance: The Provincial Cabinet of Khyber Pakhtunkhwa in its Special Cabinet meeting held on 19/06/2026 has been pleased to sanction Legal Allowance @ One hundred and Twenty Percent (120 %) on the Running Basic Pay Scales of 2022 to the following designated officers of Legislation Wing of Law, Parliamentary Affairs & Human Rights Department, Government of Khyber Pakhtunkhwa w.e.f 1st July, 2026:-

1.	Chief Legislation Officer	BPS-20
2.	Additional Legislation Officer	BPS-19
3.	Deputy Legislation Officer	BPS-18
4.	Assistant Drafting Officer	BPS-17

2. The above allowance will be admissible subject to the following conditions:

- It will be subject to Income Tax.
- It will not be counted towards pension, commutation or gratuity.
- It will be admissible subject to the reduction of Secretariate Performance Allowance from 100% to 30%.
- It will only be admissible to the Law officers of Legislation wing, who are working against the aforementioned designations and sanctioned strength of Law Department.
- The officers of other cadres working against the aforementioned cadre post of Law Officers shall not be entitled to Legal Allowance.
- If Law Officers are posted outside of their cadre and the post carry any other allowance other than regular allowances, in that eventuality, the Law Officers shall be entitled to one of the allowances whichever is more beneficial.
- It will be admissible during waiting for posting period, however, the same will not be admissible to officers, who are on Extra Ordinary Leave (EOL) or placed under suspension or on Earned Leave sanctioned for more than 120 days.
- Officers employed on pay package other than National Pay Scale (Contract, market-based salary scale, etc.) are not entitled to this allowance.

3. The Running Basic Pay means the Running Basic Pay as drawn on 30/06/2026 under the Revised Basic Pay Scale of 2022 effective from 1st July, 2022 to 30th June, 2026.
