In continuation of this Department letter No. 2/3(F/L)/FD/2016/Vol-X dated 26.06.2018, whereby specific instructions regarding placement of public fund in banks have been issued for strict compliance.

Since Current Financial Year i.e. 2018-19 closes on 30th June 2019, hence, it is 2 imperative to reconcile the closing balances in all designated bank accounts falling in the purview of the department concerned with respective Budget Section of Finance Department latest by 30th April 2019 alongwith duly verified bank statement for 2018-19.

This reconciliation process per-se the rules & instructions already invoked shall be 3 the prime responsibility of each PAO, Controlling Authority and DDO in respect of bank accounts falling under their purview. Moreover, balance in the bank accounts if any, remaining on June 30th 2019 shall not be available for use without its prior revival by Finance Department for next financial year i.e. 2019-20. In case of no response by the target date, the funds available in their designated bank accounts shall stand frozen and no further transaction could be made out of their designated bank account by the department concerned.
