NOTIFICATION:

No. FD (SOSR-IV)/3-21/2025/Executive Allowance: In pursuance of the decision of the Provincial Cabinet in its special meeting held on 13.06.2025 and in supersession of all previous notifications regarding Executive Allowance, the Government of Khyber Pakhtunkhwa has been pleased to revise Executive Allowance to the officers working against the Scheduled posts from BPS-17 to BPS-21 to the tune of 1.2 Running Basic Pay per month w.e.f. 1st July, 2025.

2. The Provincial Government of Khyber Pakhtunkhwa is further pleased that 20% of the difference between the running basic pay and the initial basic pay deducted as part of "Pay as You Go" Pension Contribution stands discontinued w.e.f 1st July, 2025.

3. The above allowance will be admissible subject to the following conditions:

- i. It will be subject to Income Tax.
- ii. It will not be counted towards pension and commutation/gratuity.
- iii. Executive Allowance will be admissible to only those officers who are posted by Establishment and Administration Department, Government of Khyber Pakhtunkhwa.
- iv. It will be admissible to Officers on Special Duty (OSD), however, the same will not be admissible to officers who are on Extra Ordinary Leave (EOL) or Suspension or on Earned Leave more than 120 days.
- v. Those officers posted on deputation against the Scheduled posts shall either draw Executive Allowance OR Cadre specific allowance plus deputation allowance; whichever is more beneficial.
- vi. Officers employed on pay package other than National Pay Scale (Contract, market-based salary scale, etc.) are not entitled to this allowance.
- vii. This allowance shall not be admissible to the officers in the receipt of Senior Executive Allowance.
