GRANT OF ADHOC RELIEF ALLOWANCE - 2018 @ 10% OF BASIC PAY OF THE CIVIL EMPLOYEES OF THE PROVINCIAL GOVERNMENT

Dear Sir.

The Competent Authority is pleased to sanction, w.e.f 1st July, 2018 and until further orders, an Ad-hoc Relief Allowance - 2018 @ 10% of basic pay to all the civil employees of the Provincial Government as well as contract employees employed against civil posts in Basic Pay Scales on standard terms & conditions of contract appointment.

- The amount of Adhoc Relief Allowance 2018:-2.
 - will be subject to Income Tax,
 - ii. Will be admissible during leave and entire period of LPR except extraordinary leave,
 - iii. will not be treated as part of emoluments for the purpose of calculation of pension/gratuity and recovery of House Rent.
 - iv. Will not be admissible to the employees during the tenure of their posting / deputation abroad.
 - v. Will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them had they not been posted abroad.
- The term "Basic Pay" for the purpose of Adhoc Relief Allowance -2018 will also include the amount of personal pay granted on account of annual increment(s) beyond the maximum of the existing pay scales.

4. The above Adhoc Relief Allowance – 2018 shall be accommodated from within the budgetary allocation for the year 2018-19 by the respective departments / organizations and no supplementary grants would be given on this account.
