#### AN ORDINANCE

*to amend the North-West Frontier Province  
Hydel Development Fund Ordinance, 2001.*

WHEREAS it is expedient to amend the North-West Frontier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ordinance No. XXVI of 2001) for the purposes hereinafter appearing;

AND WHEREAS the Governor of the North-West Frontier Province is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the Proclamation of Emergency of the fourteenth day of October, 1999, as amended upto date, and the Provisional Constitution Order No. 1 of 1999, read with Article 4 of the Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of the North-West Frontier Province is pleased to make and promulgate the following Ordinance:

1. **Short title and commencement.**—(1) This Ordinance may be called the North-West Frontier Province Hydel Development Fund (Amendment) Ordinance, 2002.

ACT

*further to amend the North-West Frontier Province  
Hydel Development Fund Ordinance, 2001*

PREAMBLE.---WHEREAS it is expedient further to amend the North-West Frontier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ord. No. XXVI of 2001);

It is hereby enacted as follows:

1. Short title and commencement.---(1) This Act may be called the North-West Frontier Province Hydel Development Fund (Amendment) Act, 2003.

(2) It shall come into force at once.

Amendment of section 4 of N.-W.F.P. Ord. No. XXVI of 2001.---

In the North-West Frontier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ord. No. XXVI of 2001), in section 4, in sub-section (1), in clause (i), for the word "Governor", the words "Chief Minister" shall be substituted.
